- No bidder participated for the procurement of Supply, Fabrication and Delivery of 1,000 pieces Presidential Awards for Filipino Individuals (PAFIOO) Polo Shirt with PhilGEPS posting reference number 8321834 dated December 23, 2021. The ABC of said procurement requirement is PhP 350,000.00 which can add to the total amount of successful EPA Project.

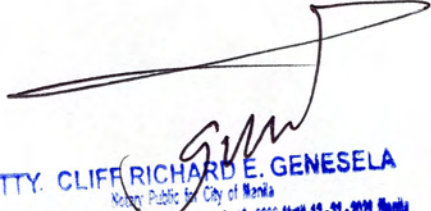

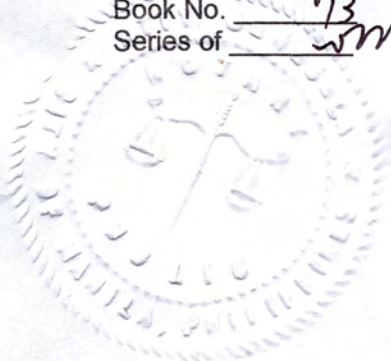
