**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE RENEWAL OF 100 LICENSES KASPERSKY ENDPOINT SECURITY FOR BUSINESS (ADVANCE) FOR ONE (1) YEAR SUBSCRIPTION**

**WHEREAS**, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Renewal of 100 licenses Kaspersky Endpoint Security for Business (Advance) for one (1) year subscription in the Philippine Government Electronic Procurement Service (PhilGEPS) website and in a conspicuous place at the premises of the CFO for seven (7) days;

**WHEREAS**, in response to the said advertisement, two (2) suppliers expressed interest in participating in the Renewal of 100 licenses Kaspersky Endpoint Security for Business (Advance) for one (1) year subscription. In particular, the said suppliers are KONEK-IT NETWORK TECHNOLOGIES INC. and COMPU CARE CENTER.

**WHEREAS**, upon opening of the Formal Quotation submitted by the two (2) suppliers at 11:00 am on July 11, 2018, the above mentioned bidders dropped bids and found eligible for the contract, when the bids were opened, the bids read passed the preliminary examination:






