

CONTRACT FOR AIR-CONDITIONING PREVENTIVE MAINTENANCE

THIS CONTRACT made and entered into by and between the following:

COMMISSION ON FILIPINOS OVERSEAS, a government agency created by virtue of the laws of the Philippines, with principal office located at Citigold Center 1345 Pres. Quirino Avenue corner Osmeña Highway, Paco Manila, represented herein by its Chief Emigrant Services Officer **MARIA REGINA ANGELA G. GALIAS** hereinafter called "CFO";

- and -

RBIEL AIR, a duly organized and existing under the laws of the Philippines, with principal office located at 295-B Visayas Avenue, Bahay Toro, Tandang Sora, Quezon City, represented herein by its Marketing Supervisor, **REYNALDO DASAS**, hereinafter called the "SUPPLIER";

WHEREAS, the CFO through its Administrative and Finance Division, conducted a small value procurement for the One (1) year Contract for the Supply of labor, tools and technical supervision for the general cleaning and preventive maintenance and checking of various air-conditioning unit of CFO for FY 2018 (hereinafter, the "Goods and Service") and the bid of the Supplier in the total amount of One Hundred Forty Seven Thousand Two Hundred Pesos (Php 147, 200.00) (hereinafter called the "Contract Price") was determined to be the lowest calculated and responsive quotation (attached as Annex "A");

WHEREAS, the Notice of Award was issued to the Supplier on May 30, 2018 (attached as Annex "B");

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

1. In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the General and Special Conditions of Contract referred to in Annex C and D, respectively.

3. In consideration of the payments to be made by the CFO to the Supplier, the Supplier hereby covenants with the CFO to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.



4. The CFO hereby covenants to pay the Supplier, in consideration of the provision of the Goods and Services and remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.






