**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE
SUPPLY OF LABOR AND MATERIALS TO FABRICATE THE ROLL-UP BLINDS AND
OUTDOOR SIGNAGE FOR CFO DAVAO OFFICE**

WHEREAS, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Supply of Labor and materials to fabricate and install the Double Face Signage and Roll-up Blinds for CFO Davao Office in the Philippine Government Electronic Procurement Service (PhilGEPS) website and in a conspicuous place at the premises of the CFO for seven (7) days;

WHEREAS, in response to the said advertisement, three (3) suppliers expressed interest in participating in the Supply of Labor and materials to fabricate and install the Double Face Signage and Roll-up Blinds for CFO Davao Office. In particular, the said suppliers are TECHNOADS INCORPORATED, DAVAO SIGNAGE MAKER and DOUBLE J GRAPHICS.

WHEREAS, upon opening of the Formal Quotation submitted by the three (3) suppliers at 1:00 pm on June 25, 2018, the above mentioned bidders dropped bids and found eligible for the contract, when the bids were opened, the bids read passed the preliminary examination:
