RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SUPPLY OF TOUR PACKAGE FOR THE HISTORICAL CORREGIDOR DAY TOUR

WHEREAS, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Supply of Tour Package for the Historical Corregidor Day Tour in the Philippine Government Electronic Procurement Service (PhilGEPS) website and in a conspicuous place at the premises of the CFO for seven (7) days;

WHEREAS, in response to the said advertisement, three (3) suppliers expressed interest in participating in the Supply of Tour Package for the Historical Corregidor Day Tour. In particular, the said suppliers are SUN CRUISES, INC., ASIATRAVEL.COM and TRAVEL MANAGERS INTERNATIONAL INC.

WHEREAS, upon opening of the Formal Quotation submitted by the three suppliers at 11:00 am on May 30, 2018, the above mentioned bidders dropped bids and found eligible for the contract, when the bids were opened, the bids read passed the preliminary examination:

WHEREAS, the bid submitted by SUN CRUISES, INC., with a total amount of **One Hundred Eighty Two Thousand Pesos only (Php 182,000.00)** was agreed to be the most advantageous price to the Commission on Filipinos Overseas.
