RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE RENEWAL OF SERVICE LEVEL AGREEMENT FOR THE HP SERVER, SWITCH AND P2000 ARRAY

WHEREAS, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Renewal of Service Level Agreement for the HP Server, Switch and P2000 Array for one (1) year contract in the Philippine Government Electronic Procurement Service (PhilGEPS) website and in a conspicuous place at the premises of the CFO for seven (7) days;

WHEREAS, in response to the said advertisement, only one (1) supplier expressed interest in participating in the Renewal of Service Level Agreement for the HP Server, Switch and P2000 Array for one (1) year contract. In particular, the said supplier is INTEGRATED COMPUTER SYSTEMS, INC.

WHEREAS, upon opening of the Formal Quotation submitted by the supplier at 11:00 am on July 23, 2018, the above mentioned bidder dropped bid and found eligible for the contract, when the bid were opened, the bid read passed the preliminary examination:

WHEREAS, as a result of Bid Opening, INTEGRATED COMPUTER SYSTEMS, INC. was declared the lowest Calculated and Responsive Supplier/Bidder for the Renewal of Service Level Agreement for the HP Server, Switch and P2000 Array for one (1) year contract of this underwent post-qualification.

WHEREAS, after careful evaluation of the Bid Proposal submitted by INTEGRATED COMPUTER SYSTEMS, INC, the BIDS AND AWARDS COMMITTEE and the BAC-Technical Working Group found INTEGRATED COMPUTER SYSTEMS, INC. to have passed the criteria for post-qualification and is responsive to all the requirements and conditions for technical specification as specified in the bidding documents;






