**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE RENTAL OF VENUE, ACCOMMODATION AND PROVISION OF MEALS FOR THE SEMINAR-WORKSHOP ON ISSUES OF INTERMARRUAGE IN BAGUIO CITY.**

**WHEREAS**, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Rental of Venue, Accommodation and Provision of Meals for the Seminar-Workshop on Issues of Intermarriage in Baguio City in the Philippine Government Electronic Procurement Service (PhilGEPs) website and in a conspicuous place at the premises of the CFO for seven (7) days;

**WHEREAS**, in response to the said advertisement, one (1) supplier expressed interest in participating in the Rental of Venue, Accommodation and Provision of Meals for the Seminar-Workshop on Issues of Intermarriage in Baguio City. In particular, the said supplier is VENUS PARKVIEW HOTEL.

**WHEREAS**, upon opening of the Formal Quotation submitted by the supplier at 2:00 pm on April 2, 2018, the above mentioned bidders dropped bids and found eligible for the contract, when the bids were opened, the bids read passed the preliminary examination:






