RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE RENTAL OF VENUE, ACCOMMODATION AND PROVISION OF MEALS FOR THE 2018 CFO TEAM BUILDING.

WHEREAS, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Rental of Venue, Accommodation and Provision of Meals for the 2018 CFO Team Building in the Philippine Government Electronic Procurement Service (PhilGEPs) website and in a conspicuous place at the premises of the CFO for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) suppliers expressed interest in participating in the Rental of Venue, Accommodation and Provision of Meals for the 2018 CFO Team Building. In particular, the said suppliers are ISLAND COVE HOTEL AND LEISURE PARK and REAL DEVELOPMENT CO. INC.

WHEREAS, upon opening of the Formal Quotation submitted by the two (2) suppliers at 2:00 pm on April 2, 2018, the above mentioned bidders dropped bids and found eligible for the contract, when the bids were opened, the bids read passed the preliminary examination:

WHEREAS, as a result of Bid Opening, ISLAND COVE HOTEL AND LEISURE PARK was declared the lowest Calculated and Responsive Supplier/Bidder for the Rental of Venue, Accommodation and Provision of Meals for the 2018 CFO Team Building of this underwent post-qualification.



WHEREAS, the bid submitted by ISLAND COVE HOTEL AND LEISURE PARK with a total amount of **One Hundred Eighty Eight Thousand Six Hundred Twenty Pesos only (Php 188,620.00)** was agreed to be the most advantageous price to the Commission on Filipinos Overseas.

NOW, THEREFORE, WE, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to award the bid to ISLAND COVE HOTEL AND LEISURE PARK for the contract for the Rental of Venue, Accommodation and Provision of Meals for the 2018 CFO Team Building.


