RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE HIRING OF SPEAKER/TRAINOR FOR ONE (1) DAY TRAINING COURSE FOR PROJECT MANAGEMENT FOR CFO PERSONNEL

WHEREAS, the Commission on Filipinos Overseas (CFO) posted the Request for Quotation for the Hiring of Speaker/Trainor for 1 day training Course for Project Management for CFO personnel in the Philippine Government Electronic Procurement Service (PhilGEPS) website and in a conspicuous place at the premises of the CFO for seven (7) days from February 9-16, 2018;

WHEREAS, in response to the said advertisement, only one (1) supplier expressed interest in participating in the Hiring of Speaker/Trainor for 1 day training Course for Project Management for CFO personnel. In particular, the said supplier is PMF PROFESSIONAL ADVANCEMENT AND CONTINUING EDUCATION;

WHEREAS, upon opening of the Formal Quotation submitted by the supplier at 2:00 pm on February 16, 2018, the above mentioned bidder dropped bid and found eligible for the contract, when the bid were opened, the bid read passed the preliminary examination:






