WHEREAS, the Commission on Filipinos Overseas posted the Invitation to Apply for the Eligibility and Bid for the Rental of Venue, Accommodation and Provision of meals for the 16th PSO Conference for FY 2018 in the PhilGEPS website (www.philgeps.gov.ph) from March 2, 2018 to March 23, 2018;

WHEREAS, in response to the said advertisement, only one (1) supplier expressed interest in participating in the Rental of Venue, Accommodation and Provision of meals for the 16th PSO Conference for FY 2018. In particular, the said supplier is PHILIPPINE DIAMOND HOTEL & RESORT, INC.;

WHEREAS, at 2:00 pm on March 23, 2018, the deadline for the submission and Opening of bids, the above mentioned bidders dropped bids and found eligible for the contract, when the bids were opened, the bids read passed the preliminary examination:


