Greetings from the Commission on Filipinos Overseas (CFO)!

We are pleased to submit to your office the CFO's Agency Information Inventory, Freedom of Information (FOI) Registry, and Summary for the second quarter of 2018, in compliance with FOI – MC No. 01 s. 2016.

For 01 April to 30 June 2018, the CFO received and processed a total of 8 requests, 4 of which came through standard FOI forms or letters, while 4 were lodged through the eFOI portal. The following table provides a summary of the CFO's FOI Registry for the second quarter of 2018:
