Greetings from the Commission on Filipinos Overseas (CFO)!

We are pleased to submit to your office the CFO's Agency Information Inventory and Standard Freedom of Information (FOI) Registry for the first quarter of 2018 in compliance with FOI – MC No. 01 s. 2016.

For 01 January 2018 to 31 March 2018, the CFO received and processed a total of 20 requests, 13 of which came through standard FOI forms or letters, while 7 were lodged through the eFOI portal. The following table provides a summary of the CFO's FOI Registry:
